Students may begin scheduling with their advisor on Thu., Oct. 26, 2017. Students may schedule via WIREd or by phone beginning on Thu., Oct. 26, 2017.

If you have scheduled your class by Wed., Dec. 6, 2017, a bill will be mailed. After Dec. 6, 2017, bills will no longer be mailed and you must pick one up at the Cashier's Office, GUN 125. The tuition due date is Thu., Dec. 14, 2017.

If your bill indicates you need a Certificate of Residence, please refer to the section on Residency Requirements.

Late Registration with a \$60 late fee will be accepted on a space availability basis on Tue., Dec. 26, 2017.

Students may add/drop through Tue., Dec. 26, 2017.

The college periodically drops the schedules of students who have not completed the registration/payment process. This means the course you selected will no longer be reserved. Drop dates are as follows: Dec. 14, 21 and 26.

Refunds and withdrawals should be applied for in-person at the Registrar's Office, Guenther Enrollment Services Center, Room 136.

The effective date of the withdrawal is the date the completed form is received in the Registrar's Office and is the effective date for refund calculation. If the notification is received by Thu., Dec. 21, 2017, students will be entitled to a 100% refund. Students who withdraw by Thu., Dec. 28, 2017 will be entitled to a 25% refund. The last day to withdraw is Fri., Jan. 5, 2018.
